- COUNCIL COMMITTEE APPROVES COUNCIL AGENDA ITEM
- AGENDA ITEM PLACED ON COUNCIL AGENDA
- THREE READINGS AT COUNCIL OF RESOLUTION
- COUNCIL ALLOCATES RESOURCES OR DIRECTS CITY MANAGER TO FIND RESOURCES FOR ITEM

CITY BUDGET TIMELINE

- FEBRUARY: DEPARTMENT BUDGET REQUESTS DUE TO CITY MANAGER
- MARCH: COMMISSION BUDGET REQUESTS DUE
- MARCH – AUGUST: CITY MANAGER PRIORITIZES BUDGET ITEM REQUESTS
- AUGUST: COUNCIL APPROVES FINAL BUDGET
- OCTOBER 1: NEW FISCAL YEAR STARTS
